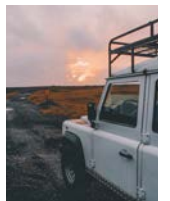

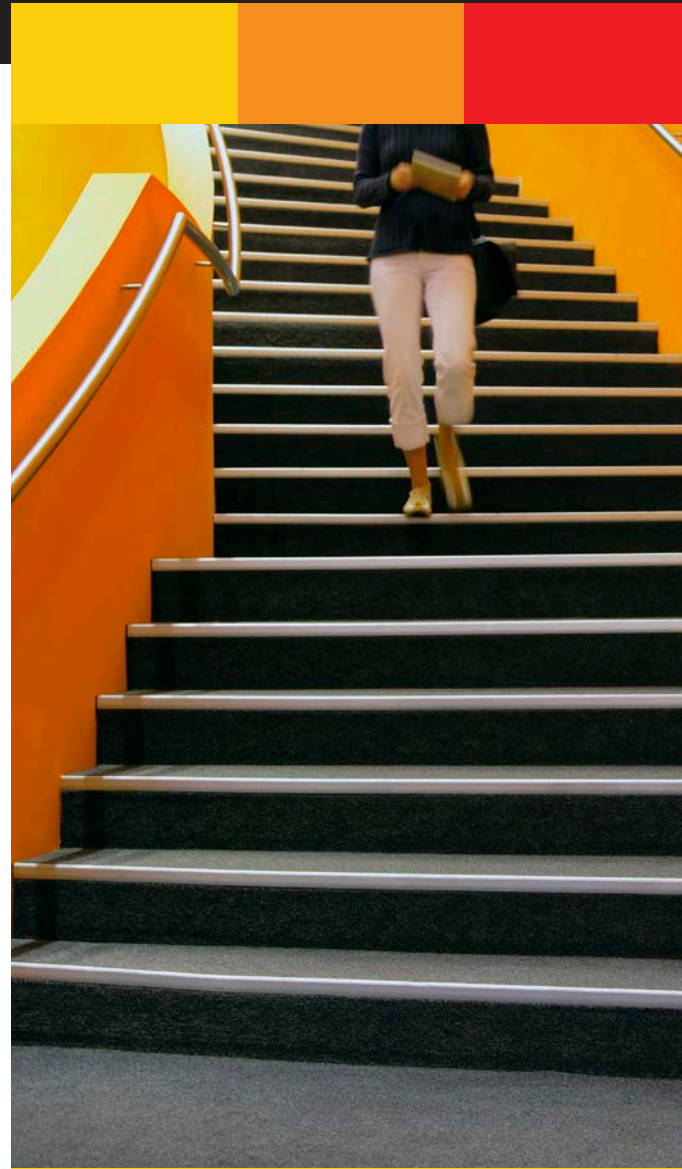
Legal compliance is often considered the benchmark and goal. But what if that is not enough?
