Reports

<u>Report for Conference</u> - report addressing the liability issues that does not contain the full justification required for a court report.

<u>Report</u> - comprehensive report suitable for presentation at trial or negotiation and conference purposes.

To provide reports typically we require some or all of the following:

- Site inspection / Client interview
- Notice / Statement of Claim Defence
- A relevant medical report
- Interrogatories / Discovery
- Loss Adjusters / WorkCover Reports

Payment Options

There are a number of payment options available. Typical payment options are:

- Capped Fee / Fee Waiver
 Work Scoped
 Guaranteed Maximum Fee
